## Introduction

It is our policy that all children should wear school uniform when attending school, or when participating in a school-organised event outside normal school hours.

## Aims and objectives

Our policy is based on the notion that a school uniform:

- promotes a sense of pride in the school;
- engenders a feeling of community and belonging;
- is practical and smart;
- identifies the children with the school;
- is not distracting in class;
- makes children feel equal to their peers in terms of appearance;
- is regarded as suitable, and good value for money, by most families;
- has been designed with health and safety in mind.


## Our School Uniform Comprises of

Royal blue sweat shirts or cardigan*
Grey pinafore/skirt
Grey/black trousers/shorts
Powder blue polo shirt*
Black flat soled shoes, flat soled boots or closed toe sandals (not trainers)
Blue and white gingham dresses

## PE

Blue shorts* or PE skirts (Blue skirts may be worn in KS2)
Powder blue King Charles tee shirt*
Pumps or trainers.
Please note that during the winter months trainers are advised and tracksuits are permitted.
*Items marked with an asterisk are available with school branding from Castle Sports and Uniform in Falmouth. Uniform in our school colours is also available from most high street shops and supermarkets.

## Jewellery

On health and safety grounds, we do not allow children to wear jewellery in school. The exceptions to this rule are studs in pierced ears, and small objects of religious significance, such as a crucifix on a chain. We ask the children either to remove these objects during PE and games, or to cover them with a plaster.

## Alternative Uniform

At King Charles we place great value on fellowship and family. In support of this, children who are members of community groups such as Cubs, Beavers, Scouts, Rainbows, Brownies or Guides are invited to wear these uniforms to school on the day that they attend that group.
Our aim is that the children take a pride in being part of a community group.

## Hair

The school does not permit children to have haircuts that could serve as a distraction to other children. We also ask that it is of a natural colour and for long hair to be tied back sensibly, so as not to hinder the child during the school day.

## Footwear

The school wants all children to grow into healthy adults. We believe that it is dangerous for children to wear shoes with platform soles, high heels or with wheels built into the sole in school, so we do not allow these. Neither do we allow children to wear trainers to school; these are appropriate for sport or as leisurewear, but are not in keeping with the smart appearance of a school uniform. We require all children to wear the types of shoe described in the uniform list.

## The Role of Families

We ask all families who send their children to our school to support the school uniform policy. We believe that families have a duty to send their children to school correctly dressed and ready for their daily schoolwork. Families should ensure that their child has the correct uniform, and that it is clean and in good repair.

If any family would like the school to modify the uniform policy, they should make representation, in the first instance, to the Headteacher.

The school welcomes children from all backgrounds and faith communities. If there are reasons, e.g. religious objections or practices, why families want their child to wear clothes that differ from the school uniform, the school will look sympathetically at such requests. Similarly, should an item of school uniform prove problematic for a pupil with specific learning/mobility needs, then families are invited to draw this to the attention of the Headteacher.

The school will not treat the above pupils unfavourably.

## The Role of Governors

The Local Governing Body supports the Headteacher in implementing the school uniform policy. It considers all representations from families regarding this policy, and liaises with the Headteacher to ensure that the policy is implemented fairly and with sensitivity.

It is the Governors' responsibility to ensure that the school uniform meets all national regulations concerning equal opportunities, and that our school uniform policy is consistent with our policy on equal opportunities.

Governors ensure that the school uniform policy helps children to dress sensibly, in clothing that is hardwearing, safe and practical.

## Monitoring and Review

When monitoring this policy, the Governing Body will:

- seek the views of families, to be sure that they agree with the policy, and support it;
- consider with the Headteacher, any requests from families for individual children to have special dispensations;
- require the Headteacher to report to the Governors on the way in which the policy is being implemented.
